The selected candidates will be liable to be posted at any of the Departments/Divisions (branches of KSIDC) in which the Corporation is interested. The online application submission link will open on **11.12.2019 (10:00 am)**. The last date for submitting the online application is **20.12.2019 (5:00 pm)**.

Selection Methodology

The applications will be subjected to a scrutiny based on the details provided by the candidate, and a list of candidates eligible for the written test will be prepared. A shortlist of the candidates who qualify the written test will be prepared, and those candidates will have to appear for a group discussion and an interview. The appointment of candidates will be based on the combined score for written test, group discussion and interview subject to the fulfillment of other eligibility criteria, as per the norms of KSIDC.

- Scan the latest photograph of the candidate and upload the same in the space provided in the online application [scanned image shall be less than 200KB in *.JPG format only]
- Candidate shall make his/her signature on a white paper, scan the same and upload it in the space provided in the online application [scanned image shall be less than 50KB in *.JPG format only]
